Formats and methods of grade labeling for foods and drinks, and oils and fats

1 Scope

This document specifies formats and methods of grade labeling for foods and drinks, and oils and fats listed in the left column of **Table 1** provided by product handles, production process managers, distribution process managers, overseas product handles, overseas production process managers, and overseas distribution process managers according to provisions set forth in Paragraphs 1 through 3 of Article 10 and Paragraphs 1 through 3 of Article 30 of the Act on Japanese Agricultural Standards (Act No. 175 of 1950).

2 Format of grade label

The format of the grade label shall be as shown in the right column of **Table 1** for each item of foods and drinks, or oils and fats listed in the left column.

3 Method of grade labeling

The method of grade labeling shall be as follows:

- a)** Each grade label shall be affixed on an invoice, or at a readily identifiable location on each container or package.
- b)** Characters, illustration, and other matters to show the details of the Japanese Agricultural Standards related to the grading may be shown in the vicinity of the format of grading labeling. In this case, any matter that could cause the general consumer to misunderstand the details of the Japanese Agricultural Standards related to the grading shall not be shown.

Format A of grade label

The format of the grade label shall be as shown in **Figure A.1**

- a) When a grade label is affixed on each container or package, the outer diameter of the circle of the grade label shall be as shown in **Table A.1**.

- b)** The width of the edge of the circle shall be 1/20 of the outer diameter of the circle.
- c)** The height of the JAS characters shall be 3/10 of the outer diameter of the circle.
- d)** The name of the certification body shall be printed in the vicinity of the circle. An abbreviation may be used for the name of the certification body.
- e)** The name of the certification body may be omitted for carbonated drinks (limited to grade labeling on the bottle cap), fruit juice (limited to grade labeling on the bottle cap), and foods and drinks, and oils and fats with a displayable area of approximately 150 cm² or less.

Format B of grade label

The format of the grade label shall be as shown in **Figure B.1**

- a) When a grade label is affixed on each container or package, the outer diameter of the circle of the grade label shall be as shown in **Table B.1**.

Canned bamboo shoots and bottled bamboo shoots (limited to whole and halves), large canned bamboo shoots [limited to whole (excluding whole with defects) and halves], canned peach and bottled peach (limited to halves), canned pear and bottled pear (limited to halves), canned 'fruit mitsumame' and bottled 'fruit mitsumame', soy sauce (Shoyu) (limited to grading labeling on containers or packages containing 201 mL or more and less than 1 800 mL), jams, Worcester sauces, tomato ketchup, chilled meat ball, boiled and dried small fishes, and canned corned beef and bottled corned beef	10 mm or more

- b)** The width of the edge of the circle shall be $1/20$ of the outer diameter of the circle.
- c)** The height of the JAS characters shall be $3/10$ of the outer diameter of the circle.
- d)** The height of the characters of classification shall be $1/5$ of the outer diameter of the circle.
- e)** The classification labeling may be omitted when the classification of following items is Normal grade: canned bamboo shoots and bottled bamboo shoots (limited to whole and halves); large canned bamboo shoots [limited to whole (excluding whole with defects) and halves]; canned peach and bottled peach (limited to halves); canned pear and bottled pear (limited to halves); canned 'fruit mitsumame' and bottled 'fruit mitsumame'; canned corned beef and bottled corned beef; jams; or Worcester sauces.
- f)** The classification and the name of the certification body shall be printed in the vicinity of the circle. An abbreviation may be used for the name of the certification body.
- g)** The name of the certification body may be omitted for foods and drinks, and oils and fats with a displayable area of approximately 150 cm² or less.

The formats of the grade label shall be as shown in **Figure C.1** or **Figure C.2**.

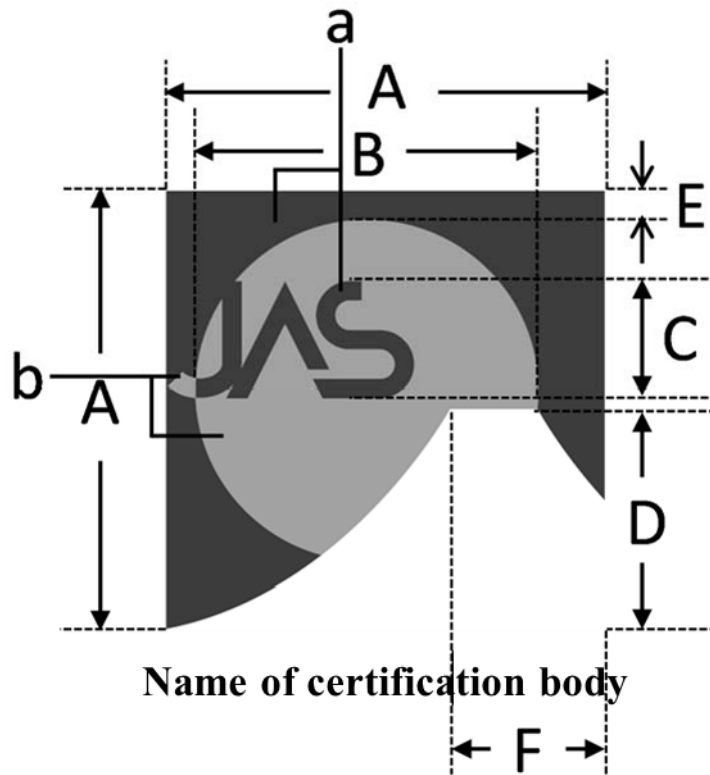


Figure C.1 — Format C of grade label (colored)

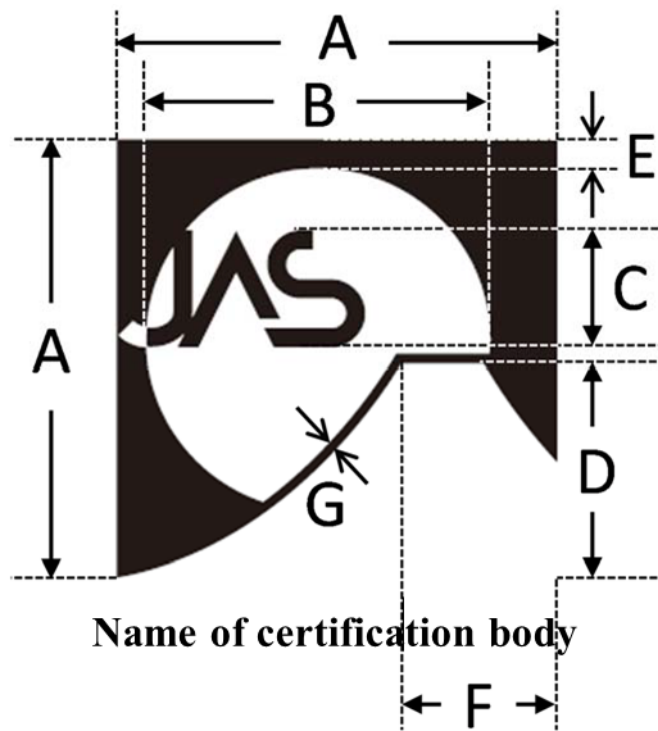


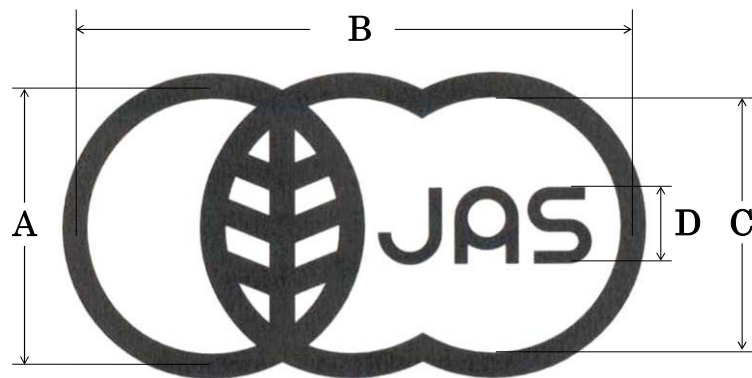
Figure C.2 — Format C of grade label (monochrome)

- a) B shall be $\frac{8}{10}$ of A, C shall be $\frac{27}{100}$ of A, D shall be $\frac{49}{100}$ of A, E shall be $\frac{65}{1\ 000}$ of A, F shall be $\frac{35}{100}$ of A, and G shall be $\frac{36}{100}$ of E.
- b) An abbreviation may be used for the name of the certification body.
- c) In **Figure C.1**, the color of part a shall be different from that of part b.

- a) A shall be at least 5 mm.
- b) B shall be twice as long as A, and D shall be 3/10 of C.
- c) The height of the characters of the certification body shall be equal to D.
- d) An abbreviation may be used for the name of the certification body.
- e) The certification number may be omitted when the production process manager, re-packer, overseas production process manager, overseas re-packer of organic products of plant origin or organic livestock products, or the importer is identifiable from descriptions printed on packages, containers, or invoices of foods and drinks, or oils and fats drinks according to the provisions of the relevant laws and regulations.

Enactment text, amendment text, supplementary provisions, etc. (Extract)

- Public Notice of Ministry of Agriculture Forestry and Fisheries No. 2815 of December 28th, 2018

Supplementary provisions

(Effective Date)

- 1 This Public Notice comes into effect as of the date of its promulgation. However, the parts related to aquaculture products by artificial seedling production techniques in Table 1 under the formats and methods of grade labeling for foods and drinks, and oils and fats after the revision by this Public Notice (hereinafter referred to as the “new public notice”) come into effect as of January 27th, 2019.

(Transitional Measures)

- 2 For certified business operators of foods and drinks, and oils and fats as listed in Annex 3, Annex 5 or Annex 6 of the formats and methods of grade labeling for the foods and drinks, and oils and fats prior to the revision by this Public Notice at the time of the enforcement of this Public Notice (certified business operators set forth by Article 46, paragraph (1), item (1), (d), 1 of Order for Enforcement of the Act on Japanese Agricultural Standards), the provisions then in force may be chosen to continue to govern the grade labeling for the foods and drinks, and oils and fats from the date of enforcement of this Public Notice to March 31st, 2022, notwithstanding the grade labeling according to Annex C of the new public notice.

This Public Notice comes into effect as of April 16th, 2020.
